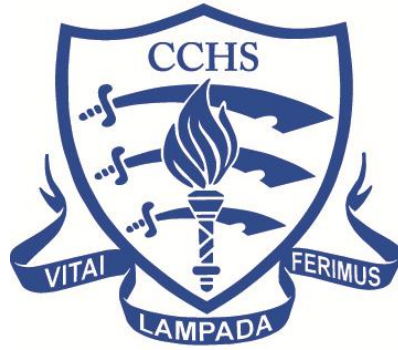

# Privacy Notice for delivery of the curriculum and pastoral care

We use personal information, for example:

- Names and address
- Contact details
- Date of birth
- Education attainment
- Emergency contacts
- Family relationships
- Travel to School Arrangements
- General case information.

We may also use special category personal information, for example:

- Health information
- Ethnicity
- Religion.

This information is provided by parent/carers, the local authority, and any previous education settings. It is used to deliver our statutory education duties, assure the health and wellbeing of our pupils. It helps us to improve our services and handle complaints. This information will be held for 25 years from the date of birth of the student. When a pupil changes school, this record will go with them and will not be retained by the previous school, other than to meet statutory returns.

### **Data Processors**

We use education platforms/systems/apps to enhance the way we deliver our education services and keep data secure. The providers of those services are data processors for this information. Our processors only process personal data in accordance with our written instructions, which ensure data is processed lawfully and safely.

No personal information is routinely available outside of the UK. Should a transfer of personal information be necessary we will only do so where it is permitted by law and where appropriate safeguards are in place.
