Citizenship



Friday gone, 24th February, marked the one-year anniversary of Russia's invasion of Ukraine. The plight of children was rightly highlighted, including the disruption to their education.

On Friday coming, we will be wearing something red, a colour common to both the Turkish and Syrian flags, as we raise funds to support the people of these two countries recovering from shattering earthquakes. Again, news coverage has drawn attention to the impact of these natural disasters on the lives of children.

In the privileged West, we often hear stories of young people being disinterested in education, disliking subjects and being disenchanted with school. This must be strange to young people in the Global South, who often do not have such a straightforward access to schooling.

This brings us to the concept and practice of citizenship in our country, our communities and our own school. Citizenship bestows rights on us and requires responsibilities of us. Just as this is true out in society, so it is in our own school community. We recently published, as the Spring Term change@cchs update, the CCHS Citizenship Programme. This represents a culmination of thoughts and experiences inspired by the standards set and actions taken by both students and staff.

We have framed this with key United Nations documents and our own school heritage.

UN Context

Principles (1 and 4) of the United Nations Convention on the Rights of the Child provide an international inspiration for work relating to young people:

Principle 1

"States parties shall respect and ensure the rights set forth in the present convention to each child within their jurisdiction without discrimination of any kind, irrespective of the child's parents or legal guardian, race, colour, sex, language, religion...national, ethnic or social origin, poverty, disability, birth or other status."

Principle 4

"States parties shall assure to the child who is capable of forming his or her own views the rights to express those views freely in all matters affecting the child, the view of the child being given due weight in accordance with the age and maturity of the child."
